OVERVIEW

As of November 30, 2023, General and Utility Fund combined revenues are \$5,830,208. This is 13.0% of the annual budgeted amounts.

Combined expenses and encumbrances of \$6,284,226 are 12.6% of the annual budget. November 30th marks the second month of the FY 2024 Budget Year. Therefore, the year to date budget percentage for budgetary comparison is 16.7%.

YEAR TO DATE OVERVIEW

Through November 30th, General Fund non-property tax revenues of \$1,909,877 are (\$117,161) less than originally projected. Total revenues (including Property Taxes) are (\$686,405) less than projected and are down (19.8%) compared to the same period in the prior fiscal year. The Dallas County Tax Office delayed the mailing of certain tax notices pending the outcome of the November 7, 2023 election to increase homeowner exemptions.

PROPERTY TAXES

Tax collections of \$1,534,225 year to date have been received. Year to date, 8.3% of the annual budget has been collected. In the prior fiscal year 12.4% had been collected at this time.

SALES TAXES

Total revenues of \$1,024,979 are \$21,260 more than projected year to date. Current year revenue is (\$88,121) less than this time last year. The Town has a repayment arrangement for taxes received from a City of Dallas vendor. The State Comptroller will withhold \$18,396 from the Town's monthly sales tax payment through April 2029.

MIXED BEVERAGE TAXES

Mixed Beverage Tax receipts of \$79,963 are \$6,090 more than projected for this time of the year and \$1,427 more than this time last year. Mixed Beverage Taxes are received monthly.

FRANCHISE FEES

Franchise Fees total \$218,902 which is \$11,633 more than projected and down (\$2,096) when compared to the amount received during the same period in the prior fiscal year. Franchise Fees are received monthly and quarterly with the exception of the Natural Gas franchise fee, which is one-time payment received each year in the month of February.

LICENSES AND PERMITS

Revenues of \$234,560 are (\$148,765) less than projected year to date, and are (\$203,117) less than the amount received prior year to date. In FY 2023, \$130,000 in permit revenue was received from a retailer in the Highland Park Shopping Village. Licenses and permits accounts primarily for building permits, but also includes electrical and alarm permits, beverage and carriage service licenses.

CHARGES FOR SERVICES

Revenues of \$180,862 are (\$13,618) less than projected year to

date. Revenues are less than the previous fiscal year by (\$9,598), primarily due to a decrease in ticket revenue.

FINES AND FORFEITURES

Total revenues of \$47,517 are \$484 more than projected through the end of November and \$15,683 more than the same period in the prior fiscal year.

EARNINGS ON INVESTMENTS

Interest earnings of \$65,861 are \$9,613 more than projected.

MISCELLANEOUS REVENUES

Total revenues of \$57,233 are down (\$4,801) from the amount projected through November. Miscellaneous revenues include penalties on delinquent property taxes, tower lease rental charges, donations, contributions, and other non-major revenues.

TRANSFERS

Biannual transfers consist of a cost allocation from the Utility Fund for the fund's share of G&A expenses and a transfer from the Court Security Fund to the General Fund for payroll related costs associated with court security.

YEAR TO DATE OVERVIEW

November 30, 2023, marks the second month of the FY 2024 budget year. The year to date budget percentage for budgetary comparison is therefore 16.7%. Total General Fund expenditures and encumbrances of \$4,855,058 are 15.1% of the annual budget.

PUBLIC SAFETY

Public Safety expended and encumbered 16.9% of the departmental budget or \$2,906,954.

DEVELOPMENT SERVICES

Development Services expended and encumbered 18.2% of the departmental budget or \$60,617.

PARKS

Parks has expended and encumbered \$458,363 or 25.0% of the departmental budget.

SWIMMING POOL

Swimming Pool has expended and encumbered \$28,766 or 10.4% of the departmental budget.

FINANCE

Finance has expended and encumbered \$246,225 or 20.6% of the departmental budget.

NON-DEPARTMENTAL

Non-Departmental has expended and encumbered \$179,741 or 26.5% of the departmental budget.


INFORMATION TECHNOLOGY

Information Technology has expended and encumbered \$356,914 or 43.7% of the departmental budget.

TRANSFERS

Biannual transfers include a transfer to the CIP Fund for infrastructure maintenance / rehabilitation. Transfers to the Equipment and Technology Replacement Funds accumulate resources for future equipment and technology purchases. A transfer to the Building Maintenance Fund supports the operational and maintenance budgets of Town Hall and the Service Center. Transfers to the Internal Service Funds occur once a year in January.

YEAR TO DATE OVERVIEW

Total Utility Fund operational revenues (excluding transfers) of \$2,386,106 are \$277,796 more than projected year to date and are up 9.7% when compared to the amount received through the same period in the prior year.

WATER SALES

Revenues totaling \$1,690,105 are \$178,296 more than projected year to date. Water sales are up \$103,779 when compared to the amount of revenue generated during the same period last year.

SEWER CHARGES

Revenues of \$522,893 are (\$2,676) less than projected through the end of November. Revenues for sanitary sewer are up \$7,557 when compared to this same period for the previous fiscal year. Sanitary sewer billings are driven by water consumption.

OTHER CHARGES FOR SERVICES

Year to date revenues of \$13,190 are \$6,880 more than projected. This revenue source is primarily driven by charges for meter installations.

LICENSES AND PERMITS

Licenses and permits revenue (i.e. Plumbing Permits) of \$11,870 or \$1,369 more than projected and \$1,745 more than the amount received through the same period of the prior fiscal year.

FINES AND FORFEITURES

Revenues (penalties assessed on past due utility bills) of \$21,333 are \$10,232 more than the year to date projection. Late payment penalty revenue is driven by payment timing and the size of the past due balance.

EARNINGS ON INVESTMENTS

Interest earnings are \$126,147 and \$83,629 above projection.

MISCELLANEOUS REVENUE

Miscellaneous Revenue accounts for contributions, cost sharing related to repairs, maintenance, and capital projects from outside organizations.

TRANSFERS

Biannual transfers consist of a transfer from the Solid Waste Fund for the cost allocation of the Solid Waste Fund's share of Utility Fund admin costs. Additionally, transfers from the Capital Project and Storm Water Drainage Funds offset related Engineering services.

OVERVIEW

November 30, 2023, marks the second month of FY 2024 budget year. The year to date budget percentage for budgetary comparison is therefore 16.7%. Year to date expenditures, plus encumbrances and less non-cash expenditures of depreciation and bad debts, total \$1,429,168 or 8.1% of annual budget.

UTILITY ADMINISTRATION

The Utility Administration budget expended and encumbered is \$122,823 which represents 26.6% of the departmental operating budget.

WATER

At \$928,907 the Water Department has expended and encumbered 7.4% of the annual budget amount and includes \$0 related to capital improvements.

SEWER

At \$226,886 the Sewer Department has expended and encumbered 14.4% of the annual budget amount, of which \$0 relate to capital improvements.


ENGINEERING

The Engineering budget expended and encumbered \$150,552 which represents 17.4% of the departmental operating budget.

TRANSFERS

Biannual transfers to other funds include a transfer to the General Fund for the Utility Fund's share of General Fund G&A expenses and a transfer to the CIP Fund based on 5% of water and sanitary sewer revenues. A transfer to the Building Maintenance Fund is made for the Utility Fund's share of building maintenance expenditures, and a transfer to the Equipment and Technology Replacement Funds is made to fund future equipment and technology purchases. Total transfers to the Internal Service Funds occur once a year, in the month of January.

- (1) Working Capital is defined as current assets less current liabilities. The Working Capital totals have not been reduced by outstanding encumbrances because expenditures are recognized in the period the liability is incurred. As of November 30, 2023, the Town had a total of \$8,371,464 in outstanding encumbrances.
- (2) Dedicated funds represent the amount of Working Capital that has been reserved to comply with financial management policies, special purpose, or lawful requirements.
- (3) Available Working Capital is the amount of Working Capital in excess of dedicated funds.
- (4) The Reserve Fund holds proceeds from land sales completed by the Town.

CASH AND INVESTMENTS

The market value of the Town's investment portfolio at November 30, 2023 was \$60,151,412. This amount is 99.99% of the recorded book value of \$60,157,259. The Town's investment practice is to invest funds for specific maturity or call dates (passive investment management), rather than buy and sell based upon market conditions (active investment management). The total portfolio yield is 5.27%.





