

RESOLUTION NO. 009-25

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF HIGHLAND PARK, TEXAS APPROVING THE PROPOSED PROPERTY TAX RATE OF \$0.199296/100 AS THE MAXIMUM RATE ALLOWED FOR COUNCIL ADOPTION; SETTING THE PUBLIC HEARING ON THE PROPOSED MUNICIPAL PROPERTY TAX RATE FOR TUESDAY, SEPTEMBER 2, 2025 AT HIGHLAND PARK TOWN HALL AT 8:00 A.M.; REQUIRING PUBLICATION OF A NOTICE OF PUBLIC HEARING ON TAX RATE IN ACCORDANCE WITH STATE LAW; PROVIDING THAT THE FINAL PROPERTY TAX RATE IS SCHEDULED TO BE ADOPTED ON SEPTEMBER 2, 2025; PROVIDING FOR THE INCORPORATION OF PREMISES; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, Texas Tax Code Section 26.05(d) requires the Town of Highland Park (the "Town") to hold a public hearing on the proposed municipal tax rate prior to the adoption of the tax rate; and

WHEREAS, Texas Tax Code Sections 26.06(c) and 26.065 require the notice of the public hearing to be published in the newspaper and on the Town's home webpage until the conclusion of the public hearing on the tax rate; and

WHEREAS, Texas Tax Code Sections 26.06 requires the notice of the public hearing on the municipal tax rate to include the names of all members of the Town Council, showing how each voted on the proposed tax rate and indicating any absences; and

WHEREAS, the Town Council shall conduct a public hearing and adopt the tax rate by ordinance on September 2, 2025 during the regular Town Council meeting.

NOW THEREFORE, BE IT RESOLVED by the Town Council of the Town of Highland Park, Texas:

SECTION 1. That the foregoing recitals are hereby found to be true and correct findings of the Town of Highland Park, Texas, and are fully incorporated into the body of this resolution.

SECTION 2. That the Town Council approves a proposed municipal property tax rate of \$0.199296/100 as the maximum property tax rate allowed for Council adoption for Tax Year 2025.

SECTION 3. That the Town Council will conduct a public hearing on the proposed municipal property tax rate on Tuesday, September 2, 2025, at 8:00 A.M. at Town Hall prior to the adoption of the Tax Year 2025 property tax rate.

SECTION 4. That the Town Secretary and other Town personnel are hereby authorized to post and publish all notices in the official newspaper of the Town concerning the municipal property

tax rate and public hearings as required by state law, and such notices shall be continuously posted on the Town's webpage for at least seven (7) days prior to the date of the property tax rate public hearing.

SECTION 5. This Resolution shall take effect immediately from and after its passage.




